## ARP-ESSER III Plan for Use of Funds

## **Geary Public Schools**

Geary Public Schools has held meaningful consultation with stakeholders through inperson collaboration to develop a plan for the use of ARP- ESSER III funds. The following plan resulted from information gleaned during these times of consultation.

Geary Public Schools will use ESSER III funds to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with CDC guidance on reopening schools to safely open school and conduct in-person learning. Geary Public Schools had to transition to virtual instruction at various time during the entire 2020-2021 school year. However, these instances helped to enable us to be more effective during the 2021-2022 school year. The pandemic has taught us to use our local and state health agencies as resources when making the best purchase decisions from ESSER III monies to help prevent our school being shut down during a pandemic situation.

We will reserve 20% of our ESSER III funds to address the academic impact of lost instructional time. Geary Public Schools has met with students, teachers, community stakeholders, and representatives of various groups to gain ideas on how to best spend our funds to close the instructional gap of our students. The ideas that came from our collaboration to use our \$213, 731.37 include updated textbooks with technology components, continuing a credit recovery program for high school students. Enhanced after school and summer tutoring, curriculum training and support for teachers. Summer camps using evidence-based interventions. Camps will possibly include, but not be limited to, ACT Prep, STEM/Engineering camp, science camp, writing workshop camps, and reading camps that could include book clubs. These ideas will continue to grow and improve during the use of our ESSER III funds availability.

Geary Public Schools will spend its remaining ARP ESSER IIII funds consistent with the uses authorized in section 2001(e)(2) of the ARP Act. Our remaining amount, after reserving 20% for academic loss, is \$854,925.50. Geary Public Schools will follow all spending guidelines put forth by the State Department of Education.
