- We are currently preparing for the beginning of the school year.
- Pending board approval, 6th grade will be moved to the Elementary building. All classrooms—except for Title I Reading—are now located upstairs.
- We have completed enrollment, and current class sizes are as follows:
- Pre-K 3: 11
- Pre-K 4: 18
- Kindergarten: 9
- 1st Grade: 16
- 2nd Grade: 10
- 3rd Grade: 13
- 4th Grade: 17
- 5th Grade: 17
- 6th Grade: 16
- Total Enrollment: 127 students
- Professional Development for all teachers and staff will take place on Monday and Tuesday, August 4th and 5th.
- The first day of school for students is Wednesday, August 6th.
- In previous years, 5th and 6th grade PE was held from 8:00 to 8:50 a.m. Beginning this year, athletics will take place mid-day, providing a new schedule structure for upper grades.
